*I/we understand that as a part of the application process, each applicant is required to provide GVHA with a copy of their personal Equifax/Transunion/Fico credit report, dated within fifteen (15) days of the application being submitted to GVHA office. The report should outline current credit score and an overview of current liabilities. Credit reports supplementary to this application may be sent to **Commercial@gvha.ca**. Applications are not considered to be received by GVHA until the appropriate credit reports have been received.*

I/we understand that rather than real estate or real property, float homes should be thought of as personal property or chattel. The float home carries with it no interest in the land or title to the property and GVHA has no involvement with the ownership of the float home itself; GVHA provides a license to moor the float home only. Fisherman's Wharf is owned fee simple by GVHA, is not stratified.

I/we understand that GVHA makes no representations or warranties as to the condition of any individual float home, and recommends that purchasers work with a realtor who has familiarity with transactions at the facility or specifically with float homes, and that a lawyer be involved in the completion of the sale. I/we understand that GVHA recommends that purchasers get an independent marine survey to assess the condition of the float home. GVHA will not provide previous surveys on file to purchasers.

I/we understand that Fisherman's Wharf is a multi-use facility and that Docks A-C, where float homes are moored, are open to the public during facility hours. While the facility is secured overnight by upland gates, there are no gates or barriers that prevent the public from walking on the docks between the float homes. I/we understand that the facility can be quite active at times, especially in the summer, and activity on docks A-C should be expected as part of the overall lifestyle living on Fisherman's Wharf.
